

## Appointment of Non-Executive Director and Chairman

He holds an ICD.D designation from the Canadian Institute of Corporate Directors.

Non-executive director, Grant Davey, commented: “John’s demonstrated success in the uranium industry, corporate governance expertise and career spanning the resources, finance and legal sectors brings enormous value to Lotus. We welcome John and look forward to working with him to realise the potential of the Kayelekera Project.”

Under the terms of his appointment, Mr Sibley will receive an annual retainer of \$100,000 and be granted 3,000,000 zero priced options that vest subject to 18 months of continued service.
